

**EXHIBIT E – PARTICIPANT AUTHORIZATION**

**Lab Connectivity Terms of Use.** These terms of use are a legal agreement between the medical practice identified below (hereinafter referred to as “Participant”) and Laboratory Corporation of America Holdings and its subsidiaries (hereinafter referred to as “LabCorp”) governing your connection to LabCorp through CORHIO. As used in this Agreement, the term “Participant” includes all ordering physicians or other persons in the practice that are authorized to order laboratory tests on behalf of Participant under applicable laws, rules and regulations.

**Orders and Results.** If LabCorp determines that Participant qualifies for a connection to LabCorp through the CORHIO, LabCorp shall arrange with CORHIO for the installation of either a) a Uni-Directional Interface which allows LabCorp to electronically transmit patient test results to CORHIO or b) a Bi-Directional Interface which allows LabCorp to electronically transmit patient test results to CORHIO and electronically receive transmission of test requests from CORHIO. In either case, CORHIO is responsible for transmission of results reports to Participant’s system and for transmission of requisitions from Participant’s System through CORHIO to LabCorp. By signing this Agreement, Participant acknowledges and authorizes LabCorp to transmit result reports through CORHIO in this manner and based upon Participant’s relationship with the Exchange.

**Results Reports. (If neither option is chosen below, Exchange will be considered the Report of Record),**

initials	<b>Report of Record.</b> Participant understands that CORHIO will deliver the official chartable report of laboratory testing results that complies with applicable reporting laws.
initials	<b>Copy Only.</b> Participant understands that CORHIO will not deliver the official chartable report of laboratory testing results that complies with applicable reporting laws or otherwise meets the Participant’s needs. Please contact your LabCorp Account Representative to establish the LabCorp means to deliver your official chartable report of the laboratory result.

**Sharing of Data.** By agreeing to these terms of use, Participant directs LabCorp to submit laboratory tests results to CORHIO for delivery to Participant. Participant acknowledges that other practices and persons participating in CORHIO will have access to such results and other information. All terms related to participation in CORHIO, and for any permitted use or access of such data, are solely between Participant and CORHIO. LabCorp assumes no responsibility for how information is used once submitted into CORHIO, and Participant shall indemnify, defend and hold LabCorp harmless from and against any claims of any inappropriate use or release of information.

**No Supplies or Equipment.** LabCorp is not providing any supplies or equipment under this agreement. Participant is responsible for arranging separately for all hardware, software, services, items, devices, or supplies necessary for Participant to connect to CORHIO. Likewise, Participant shall be responsible for all maintenance, support and service fees which are related to Participant’s system and to connection to CORHIO.

**Compliance with All Laws and Restricted Use.** It is the intent of the parties hereto to comply with all federal, state and local statutes, regulations and ordinances, including but not limited to the Health Insurance Portability and Accountability Act of 1996 (“HIPAA”), Section 1877 of the Social Security Act (commonly known as the “Stark Provisions”) and the anti-kickback provisions set forth in the fraud and abuse sections of 42 U.S.C. 1320(a), as well as and any regulations issued thereunder and any applicable similar state laws and regulations. The parties agree that pursuant to this Agreement, LabCorp shall only provide items, devices, or supplies that are used solely to order or communicate the results of, tests or procedures provided for Participant, and that any benefit, consideration or remuneration conferred upon Participant by virtue of this Agreement is not conditioned upon the referral of Medicare or Medicaid testing to LabCorp.

**Warranty/Liability.** The connection from LabCorp to CORHIO is provided on an “as-is” and “as-available” basis. LabCorp disclaims any and all warranties with regard to CORHIO. In no event will LabCorp be liable for incidental, consequential, special or indirect damages. In jurisdictions limiting the effect of such a limitation, LabCorp’s liability is limited to the greatest extent permitted by law. LabCorp shall not be responsible for any claim in connection with the establishment or performance of CORHIO, nor for how any person may use the data once submitted to CORHIO. Participant hereby expressly releases LabCorp and agrees to indemnify and hold LabCorp harmless from any and all claims, including any and all claims for property damage, personal injuries and/or consequential, punitive or other damages which arise, or are alleged to have arisen, in connection with the establishment, operation or functioning of CORHIO.

**Term and Termination.** Either Party may terminate this agreement at any time upon 15 days’ notice.
