DAP CYE 2025



- The purpose of this webinar is to clarify the requirements for eligible providers participating in the AHCCCS Differential Adjusted Payments (DAP) Contract Year End (CYE) 2025 Program.
- DAP Participation for Eligible AHCCCS Provider Types:

- Hospitals Subject to APR-DRG Reimbursement (Type 02) excluding Critical Access Hospitals
 - Critical Access Hospitals (CAH)
 - Other Hospitals and Inpatient Facilities (Types 71, B1, B3, B5, B6, C4)
 - IHS and 638 Tribally Owned and/or Operated Facilities (Type IHS/638)
 - Nursing Facilities (Type 22)
 - Behavioral Health Outpatient and Integrated Clinics (Types 77, IC)
 - Physicians, Physician Assistants, and Registered Nurse Practitioners (Types 08, 18, 19, 31)
 - Specialty Providers: Obstetrics and Gynecology, Pediatrics, Cardiology and Nephrology (Types 08, 18, 19, 31)

What is DAP?

- DAP aims to distinguish providers that have committed to supporting designated actions that improve patients' care experience, improve members' health and reduce cost of care growth.
- An integral part of the DAP includes HIE, SDOH, and AzHDR programs.
- HIE requirements have been a key component of DAP policies since the program began in CYE 2017.
- DAP is based on CYE, contract year for AHCCCS and its MCOs – which is equivalent to federal fiscal year (FFY).
 - CYE 2024 = Oct. 1, 2023 to Sept. 30, 2024
 - CYE 2025 = Oct. 1, 2024 to Sept. 30, 2025

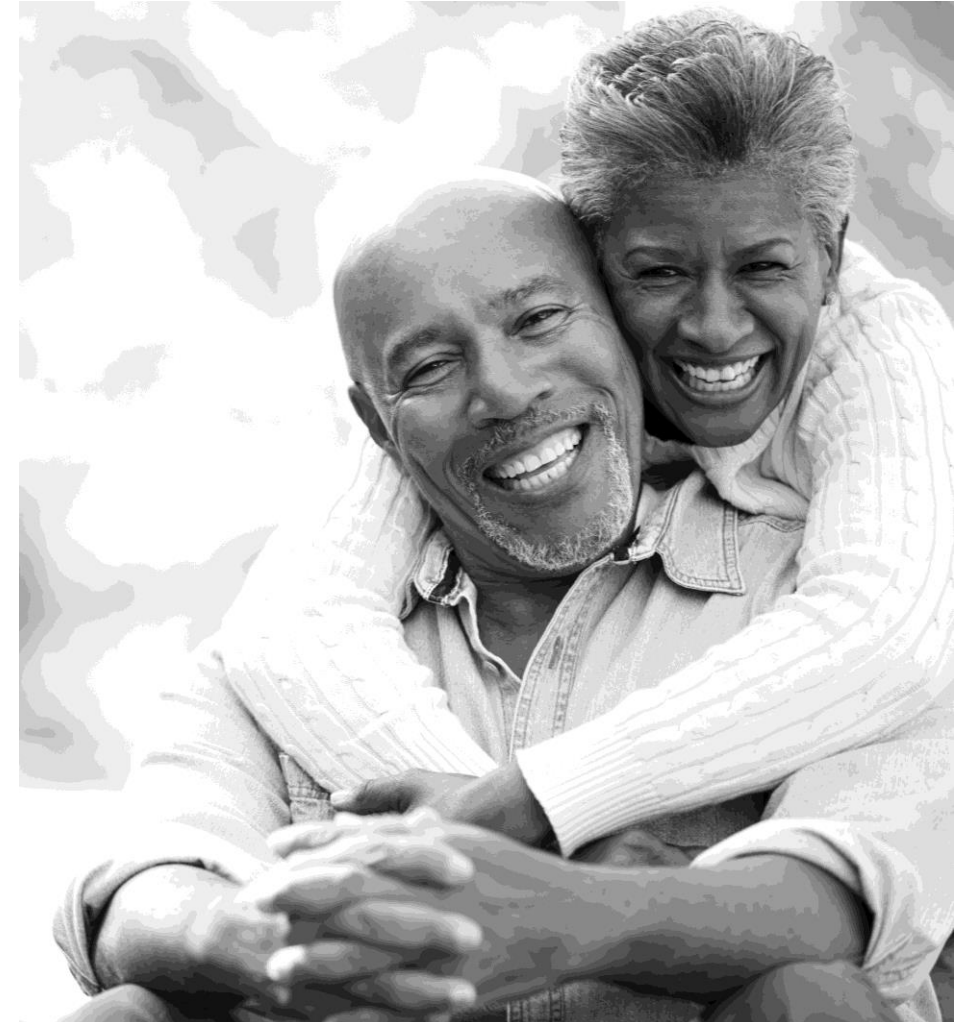

Arizona Healthcare Directives Registry (AzHDR)

Statewide Registry for Advance Directives Available to All Arizonans

- The AzHDR is designed to help honor patients' end-of-life healthcare preferences by providing seamless access to advance directives, across the continuum of care. The secure online AzHDR provides a safe place to store and make accessible Arizonans' advance directive documents so end-of-life care will be guided by one's wishes.
- The AzHDR is available at no cost and offers easy access to healthcare providers and facilities at the time of medical need.
- Participating providers can access advance directives. Providers need to sign up to participate. The registry allows for both submitting and viewing patients'/clients' advance directives.
- **Eligible hospitals and providers can get a DAP increase upon AzHDR milestone completion.**



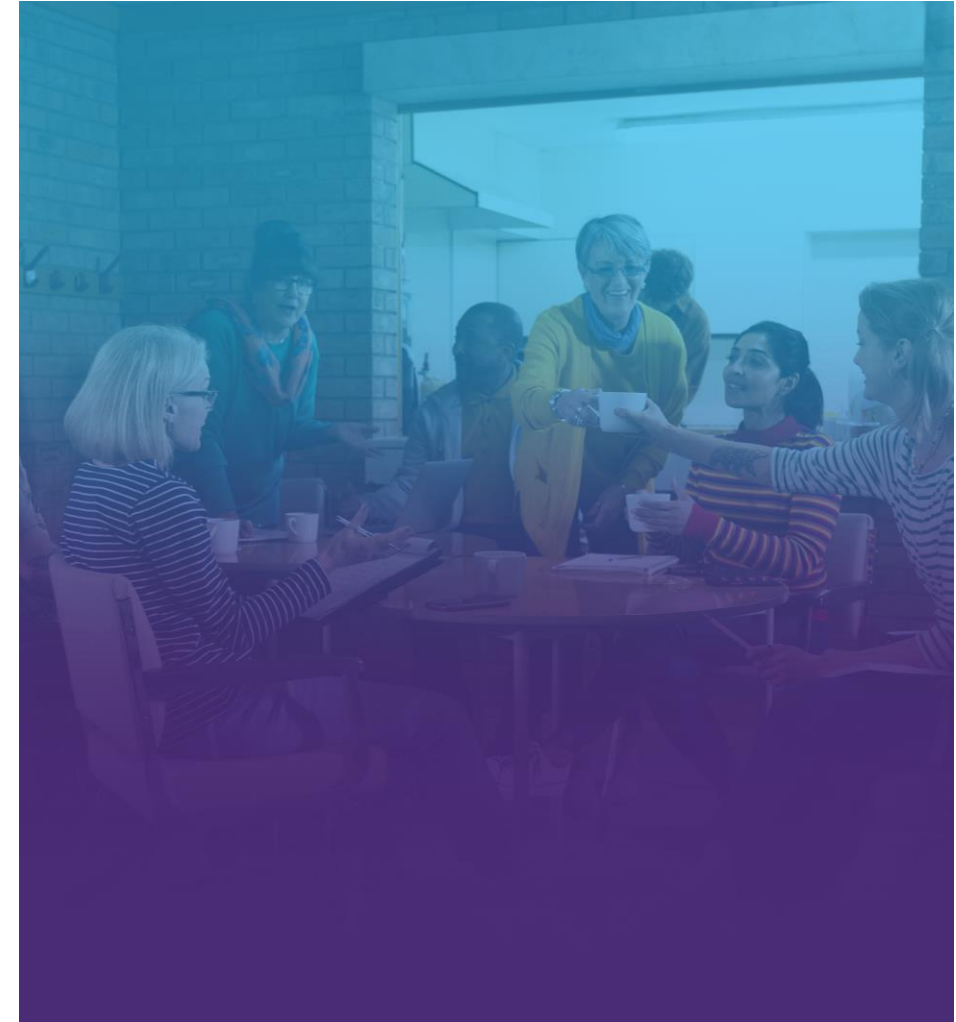

SDOH Referral System – CommunityCares

- **Single, Statewide SDOH Referral System**
Contexture teamed with AHCCCS and, in collaboration with Solari Crisis & Human Services and 2-1-1 Arizona, implemented CommunityCares to address social determinants of health (SDOH) needs in Arizona.
- **New Technology Platform**
Powered by Unite Us, the system is designed to connect **healthcare providers and community-based organizations** to streamline the referral process, foster easier access to vital services and provide confirmation when social services are delivered.
- **DAP**
Eligible hospitals and providers can get a DAP increase upon SDOH milestone completion.

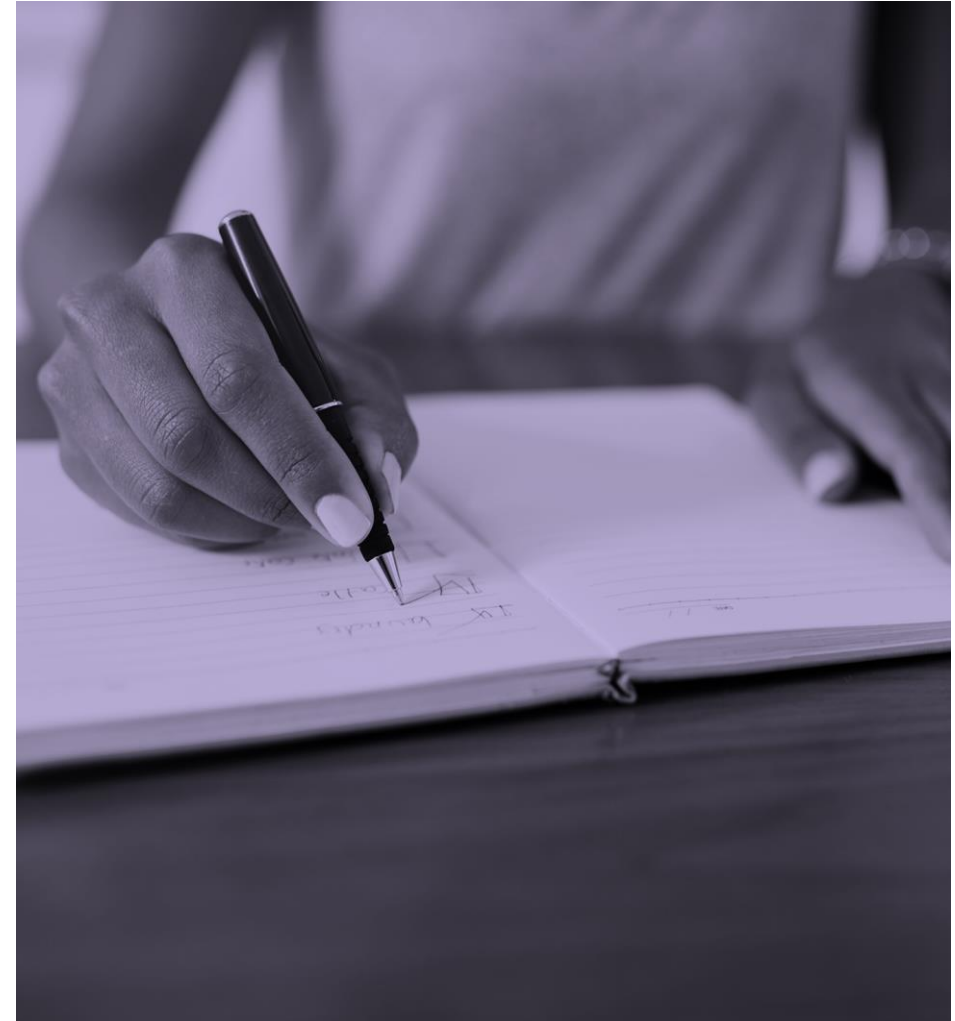

Electronically Submit ADT or Other Information

Participant

- Along with any vendor partners, complete activities related to interface development and ADT data submission.
- Important for participant to stay engaged and meet all mutually agreed upon deadlines and requirements in order to meet all DAP deadlines.

Contexture

- Provide Participant with detailed technical specifications listing the types of data required for submission within each category noted.
- Assign resources and complete all agreed upon timelines and activities, to ensure that participant meets their DAP deadline.

Complete Data Quality Indicators

Participant

- Stay engaged with Contexture's Integrations Team, complete activities related to completion of the Data Quality Analysis Tool.
- Important for participant to stay engaged and meet all mutually agreed upon deadlines and requirements in order to meet all DAP deadlines.
- Once data quality analysis is received, participant will collaboratively review the gaps identified with Contexture and develop resolution plan to address the gaps, fixing red gaps prior to go live.

Contexture

- Teams run the Data Quality Analysis.
- Share analysis with participant and discuss any gaps. Support participant in development of a resolution plan.

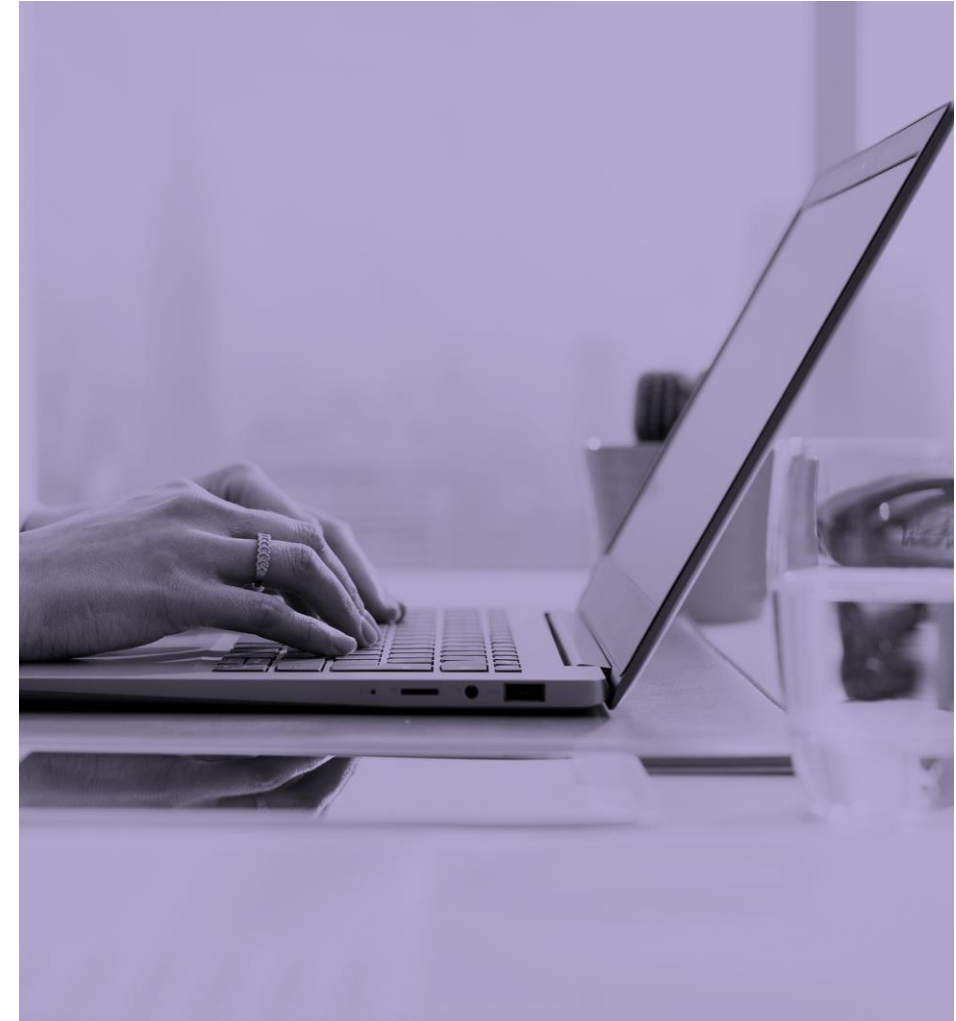
